### Agreements Settled in May

In May, 30 collective agreements were ratified, each covering 200 or more employees. These agreements covered 48,389 employees, 93% of whom were in the private sector, with the majority in the construction industry (43,160).

The overall average annual increase in base wage rates in May was 2.4%, down slightly from 2.5% reported in the previous month. In the public sector, five agreements were settled for an average annual wage increase of 1%, compared to 3% reported last month. In the private sector, 25 agreements were settled for an average annual wage increase of 2.5%, an increase from 2.4% in April.

Major settlements in May included 14 Industrial-Commercial-Institutional (ICI) and eight non-ICI agreements. These three-year agreements cover 43,160 employees and provide average annual wage increases ranging from 2% to 3.2%. The Metro Toronto Convention Centre Corporation and the Labourers' International Union of North America (LIUNA), representing 818 employees, settled an agreement for an average annual wage increase of 2.2% over three years. The Municipal Property Assessment Corporation and the Ontario Public Service Employees Union (OPSEU), representing 1,400 employees, negotiated a two-year agreement with no wage adjustments. The City of Barrie and the Canadian Union of Public Employees (CUPE) reached a three-year agreement. The agreement covers 420 employees and includes a 2% average annual increase. The Canadian Pacific Railway and Teamsters Canada (Maintenance of Way Employees Division) settled a three-year agreement, providing 611 Ontario-based employees with an average annual wage increase of 2%.

*Average Annual Wage Increase: 0.8% over three years*

### **Enersource Hydro Mississauga Inc. and IBEW, Local 636 (242 employees)**

*Average Annual Wage Increase: 3.1% over four years*

### **Toronto Community Housing Corp. and CUPE, Local 79 (385 employees)**

*Average Annual Wage Increase: 3% over three years*

## Selected Settlement Summaries

(Based on available information)

### **Labourers' Employer Bargaining Agency (ICI) and Labourers' International Union of North America, Various Locals (10,000 employees)**

*a three-year renewal agreement, effective May 1, 2010, expiring April 30, 2013*

- total wage package increase between \$2.50 and \$3.30 (depending on locations) over the term of the agreement

### **Ontario Erectors Association (ICI) and International Association of Bridge, Structural, Ornamental and Reinforcing Ironworkers, Various Locals (4,300 employees)**

*a three-year renewal agreement, effective May 1, 2010, expiring April 30, 2013*

- wage increases of \$1.25 in the first and second years and \$1.00 in the third year, representing a total wage package of \$3.50 over the term of the agreement

### **Municipal Property Assessment Corporation and Ontario Public Service Employees Union (1,400 employees)**

*a two-year renewal agreement, effective January 1, 2010, expiring December 31, 2011*

- no wage adjustments
- modifications to health care benefits and bereavement leave provisions
- addition of Family Day to the list of Designated Holidays
- employees with unused sick or vacation days will have the option in January 2011 and January 2012 to receive cash equivalent for up to a total of five (5) days in each year of the agreement

### **Operating Engineers Employer Bargaining Agency (ICI) and International Union of Operating Engineers, Local 793 (3,000 employees)**

*a three-year renewal agreement, effective May 1, 2010, expiring April 30, 2013*

- wage increases of \$1.25 in each year, representing a total wage package of \$3.75 over the term of the agreement

### **Association of Millwrighting Contractors of Ontario (ICI) and United Brotherhood of Carpenters and Joiners of America, Various Locals (3,000 employees)**

*a three-year renewal agreement, effective May 1, 2010, expiring April 30, 2013*

- wage increases of \$0.95 on May 16, 2010, \$1.15 on May 1, 2011 and \$1.40 on May 1, 2012, representing a total wage package of \$3.50 over the term of the agreement

### **City of Barrie and Canadian Union of Public Employees, Local 2380 (420 employees)**

*a three-year renewal agreement, effective January 1, 2010, expiring December 31, 2012*

- wage increases of 2% in each year
- improvements to health care benefits
- increases in stand-by pay, shift premium, safety footwear, and tool allowances
- modification to bereavement leave provision
- probationary period increased from three months to six months

The increases do not necessarily reflect the average increase for each member of the bargaining unit.
