Agreements Settled in June

In June, 29 collective agreements were ratified, each covering 200 or more employees. These agreements covered 36,238 employees, 84% of whom were in the private sector, with the majority in construction (26,950).

The overall average annual increase in base wage rates in June was 2.4%, unchanged from the previous month. In the public sector, nine agreements were settled for an average annual wage increase of 2.4%, up from 1% reported in the previous month. In the private sector, 20 agreements were settled for an average annual wage increase of 2.4%, a slight decrease from 2.5% reported in May.

Major settlements in June included four Industrial-Commercial-Institutional (ICI) and six non-ICI agreements. The ten construction agreements covering 26,950 employees include average annual wage increases ranging from 1.6% to 2.8%. In the public sector, two agreements were negotiated between the City of Greater Sudbury and the Canadian Union of Public Employees (CUPE). The inside and outside bargaining units cover a total of 1,497 employees, and each agreement provides an average annual wage increase of 2.4% over three years.

a three-year renewal agreement, effective May 1, 2010, expiring April 30, 2013

- wage increases of \$1.25 in the first year, \$1.50 in the second year, \$1.00 in the third year, representing a total wage package increase of \$3.75 over the term of the agreement

Toronto Heavy Construction Association and Labourers' International Union of North America, Local 183 (700 employees)

a three-year renewal agreement, effective May 1, 2010, expiring April 30, 2013

- wage increases of \$1.20 in both the first and second years, \$1.50 in the third year, representing a total wage package increase of \$3.90 over the term of the agreement

Toronto and Area Road Builders Association and International Union of Operating Engineers, Local 793 (2,000 employees)

a three-year renewal agreement, effective May 1, 2010, expiring April 30, 2013

- wage increases of \$1.25 in each year, representing a total wage package increase of \$3.75 over the term of the agreement

City of Greater Sudbury and Canadian Union of Public Employees, Local 4705 (1,497 inside and outside employees)

two, three-year renewal agreements, effective April 1, 2010, expiring March 31, 2013

- general wage increases of 2.5% in the first year, 2.4% in the second year and 2.3% in the third year; special wage adjustments for specific classifications in the outside bargaining unit
- improvements to extended health care benefits
- increases in shift differentials, standby premiums, and on-call pay, and allowances for safety footwear, boots, tools, and meals

Second Quarter 2010 Summary

During the second quarter of 2010, 81 collective agreements were ratified, each covering 200 or more Ontario-based employees. These agreements covered 101,523 employees, 88% of whom were in the private sector. By industry, the majority of employees were in construction (80,171), local government (6,150), and communications (2,470).

Wage Adjustments

Second quarter settlements provided an overall average annual wage increase of 2.4%, compared to 2.2% reported in the previous quarter. In the public sector, the average annual wage increase was 2.2%, up from 2.1% in the previous quarter. The private sector reported an average annual wage increase of 2.4% compared to 2.2% in the first quarter. During the second quarter of 2010, average annual wage increases were affected by settlements in construction (2.5%), local government (2.7%), and communications (2.1%).

In the second quarter of 2010, approximately 79% of all employees received average annual wage increases ranging from 2% to 2.9%, compared to 8% who received average annual wage increases ranging from 1% to 1.9%. In the public sector, 66% of employees were covered by agreements with average annual wage increases ranging from 2% to 2.9%, compared to 81% of private sector employees.

Of the total number of employees for whom agreements were reached during the second quarter of 2010, 91% were covered by three-year agreements. Approximately 97% of private sector employees and 52% of public sector employees were covered by 36-month agreements, compared to 16% of public sector employees and less than 1% of private sector employees who were covered by 24 month agreements. Negotiations resulted in settlements of a three-year duration for all employees covered by construction agreements, and for the majority of employees in both the manufacturing and non-manufacturing sectors.

Negotiations

On average, private sector agreements were ratified within 3.1 months from the start of negotiations, compared to 5.2 months in the public sector.

Of all settlements reached during the second quarter of 2010, 32 agreements covering 24% of employees were negotiated directly by the parties, compared to 44 agreements, covering 68% of employees, reached with the assistance of conciliation or mediation. Four agreements were settled by arbitration, and one agreement was reached following a work stoppage.

In the public sector, approximately 33% of employees reached settlements through conciliation or mediation, and 47% settled by direct bargaining. In the private sector, 73% of employees reached agreements with the assistance of conciliation or mediation, compared to 21% who settled by direct bargaining.

Upcoming Bargaining

Major negotiations continuing into the third quarter of 2010 involve the federal government, municipalities, police services boards, hospitals, nursing homes and homes for the aged, universities, and construction. Major agreements scheduled to expire during the third quarter include universities, Loblaws Supermarkets, and Zehrmart.

Work Stoppages

During the first six months of 2010, 33 work stoppages under Ontario jurisdiction were reported, compared to 41 reported for the same period in 2009. Work stoppages during the first six months of 2010 involved 7,394 employees and resulted in 539,140 person-days lost, compared to 35,203 employees and 400,150 person-days lost reported for the same period last year.

From January to June 2010, 15 work stoppages were reported in the manufacturing sector, a decrease from 17 reported during the same period last year. The non-manufacturing sector reported 17 work stoppages during the first six months of 2010, a decrease from 24 reported during the same period last year. During the first six months of 2010, 0.07% of the estimated working time in Ontario was lost due to work stoppages.
